All commissioners will be signers on the checking and money market accounts. A check for \$10,000 from the general checking and a check for \$10,000 from the strike team checking will be authorized and signed at the January, 2024 meeting to open the accounts. The current accounts at Westamerica will eventually be closed. Haringa seconded the motion and the motion carried.

The current Substitute Weekday Staffing Board Policy will be amended to apply to strike team absences only. A similar substitute staffing policy will be created to cover vacation/sick/other time off using funds from the general fund to pay \$180 for a 9 hour shift or \$240 for a 12 hour shift. Both policies will be presented at the January, 2024 board meeting for review and adoption.

Swartz moved that the Volunteer Association be reimbursed \$1,217.95 for duty shirts. Muller seconded the motion and the motion carried.

Commissioners Haringa and Muller will meet with Chiefs Mundello and Lundquist to review the Equipment Replacement Plan and prepare a presentation for a future board meeting.

Swartz moved that \$33,166.07 be transferred from the Special Assessment account into the General Fund to cover employee costs from July 1 through December 31, 2023. Muller seconded the motion and the motion carried.

Santa will visit Denair on December 20 for a children's party and will take a fire truck ride through Denair on December 15 and 16.

The meeting was adjourned at 6:53 p.m.
