Swartz moved that the 1986 International Type 2 be sold by sealed bids to be opened at the November board meeting. Lindquist seconded the motion and the motion carried.

Denair Fire Department will be hosting the Tri-Tip Barbecue on September 14, 2024. Woody's has donated a golf cart for the raffle.

Denair Firefighters will drive the Quint for Retired Commissioner Elwood Escobar's funeral on September 5, 2024.
