Denair Firefighters Association will present \$1,000 scholarships to two Denair High School students.

Progress on the department LED sign is continuing.

Denair Firefighters Association will host a lunch at the station for the Champ Camp students on Saturday, June 14. A team of firefighters will be attending the camp at Wonder Valley Ranch Resort in Sanger for VIP day on June 11.
