Chief Mundello reported that:

- No update on the VFC 50/50 Grant application
- OES350 is awaiting repairs
- Stanislaus County OES is implementing First Due, an emergency management system
- Quotes are being obtained to replace the surveillance camera system

Haringa moved that two credit card charges be paid without receipts: Coastal Clean, San Luis Obispo, August 16, 2025, \$38.75; and Clean n Bright Car Wash, Atascadero, August 17, 2025, \$29.25. Scott seconded the motion and the motion carried.
