

Chairman Bart Muller called the meeting to order at 6:00 p.m. Those present were Commissioners Muller, Earl Haringa, Matt Scott and Thomas Lindquist; Captain Jose Ramirez; and Board Clerk Lisa Wynn.

Scott led the flag salute.

The minutes of the May 18 meeting were approved as presented.

Captain Ramirez reported that OES350 will be repaired and back in service by mid-June.

Scott/Haringa moved to pay the bills (schedule attached) including a credit card charge of \$68.79 from United on May 10, 2026 for which there is no receipt. Motion carried.

There were 46 calls in May with the breakdown as follows: 19 EMS; 5 fire alarms; 1 gas leak; 1 grass fire; 1 injury traffic collision; 10 mutual aids; 7 public assists; 1 smoke check and 1 structure fire.

The ladder truck that was purchased in May is currently undergoing needed repairs and alterations.

Haringa moved that \$93,963.89 be transferred from the Special Assessment Fund into the General Fund to cover January through June employee costs, the costs to date for the ladder truck and the cost of the MDC tablets and accessories; and \$200,000.00 be transferred from the General Fund to Oak Valley Checking. Lindquist seconded the motion and the motion carried.

The proposed 2026-27 budget was discussed and will be finalized at the future meeting.

Scott moved that the Special Assessment rate be increased 2% for the 2026-27 tax year. Haringa seconded the motion and the motion carried.

Scott moved that Q38 be disposed of "as is" at the highest price offered. Lindquist seconded the motion and the motion carried.

Denair Firefighters Association will host a lunch at the station for the Champ Camp students on Saturday, June 13.

The County Wildland Training will be held June 5-7, 2026 at Turlock Lake.

The meeting was adjourned at 7:36 p.m.
