

Chairman Bart Muller called the meeting to order at 6:00 p.m. Those present were Commissioners Muller, Earl Haringa, Matt Scott; Mark Swartz and Thomas Lindquist; Chief Aaron Mundello; Captain Jose Ramirez; and Board Clerk Lisa Wynn.

Swartz led the flag salute.

The minutes of the June meeting were approved as presented.

Chief Mundello reported that:

- The roster stands at 30 with 2 firefighters on a leave of absence
- The City of Penjamillo, Michoacan has requested the donation of a fire engine
- Stanislaus County OES is continuing to implement First Due, an emergency management system
- OES350 is still at the shop for repairs
- Denair has partnered with Turlock Rural, Keyes and Hughson fire departments to submit a \$600,000+ turnout grant

Swartz/Lindquist moved to pay the bills (schedule attached) including a credit card charge of \$99.99 from Microsoft on March 16, 2026 for which there is no receipt. Motion carried.

There were 53 calls in June with the breakdown as follows: 31 EMS; 3 fire alarms; 2 grass fires; 3 injury traffic collisions; 7 mutual aids; 4 public assists; 1 smoke check; 1 structure fire and 1 vehicle fire.

Alterations and repairs on the ladder truck that was purchased in May are complete and the truck is scheduled to be shipped on July 13.

Swartz moved that \$189,800.00 be transferred from the Special Assessment Fund into the General Fund to cover the balance of the ladder truck; and \$189,800.00 be transferred from the General Fund to Oak Valley Checking. Haringa seconded the motion and the motion carried.

Scott moved that five nozzles and one shutoff be purchased from Hen at a cost of \$4,773.47. The funds will come from the Special Assessment Fund. Swartz seconded the motion and the motion carried.

Swartz moved that up to \$7,500.00 be allocated to purchase a new station ice machine. The funds will come from the Special Assessment Fund. Scott seconded the motion and the motion carried.

Closed session was postponed until the August meeting.

The meeting was adjourned at 7:44 p.m.
